



How this affects your energy bills

An average household would need to spend £1,223 per year on heating, hot water and lighting in this property. These costs usually make up the majority of your energy bills.

Step 3: Double glazed windows

Replace single glazed windows with low-E double glazed windows

Typical yearly saving	£109
Potential rating after completing steps 1 to 3	81 B
