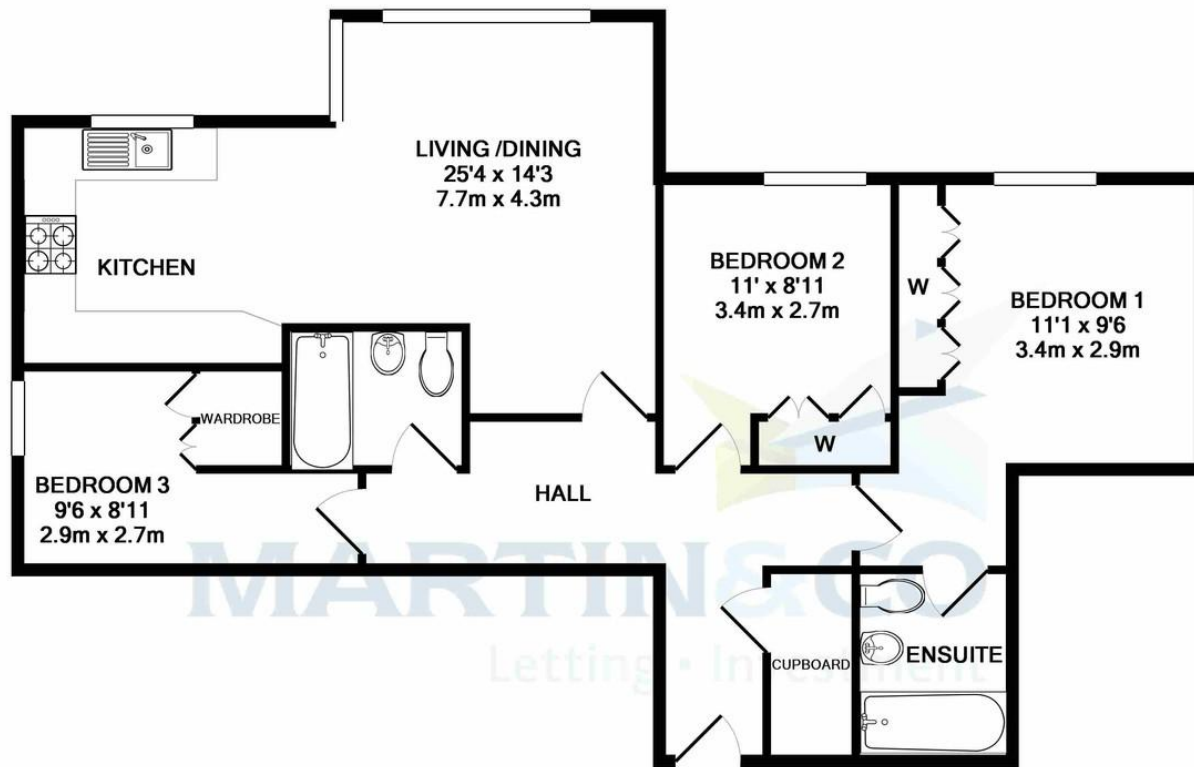

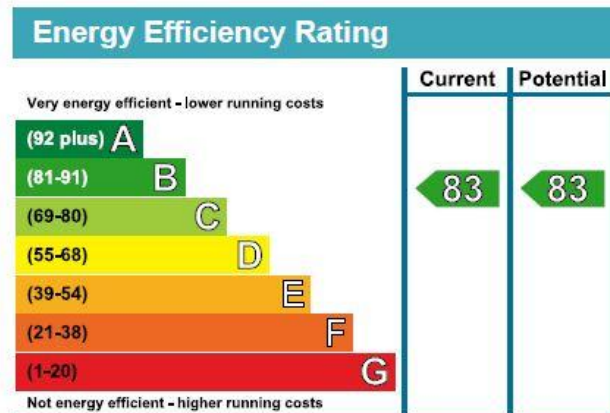
The kitchen includes Quartz worktops, Bosch appliances, Grohe bathroom fittings and hardwood internal doors. Viewing is highly recommended.

OUTSIDE There is a private car park with allocated parking for 1 car.

Reference Checks and Credit Worthiness
