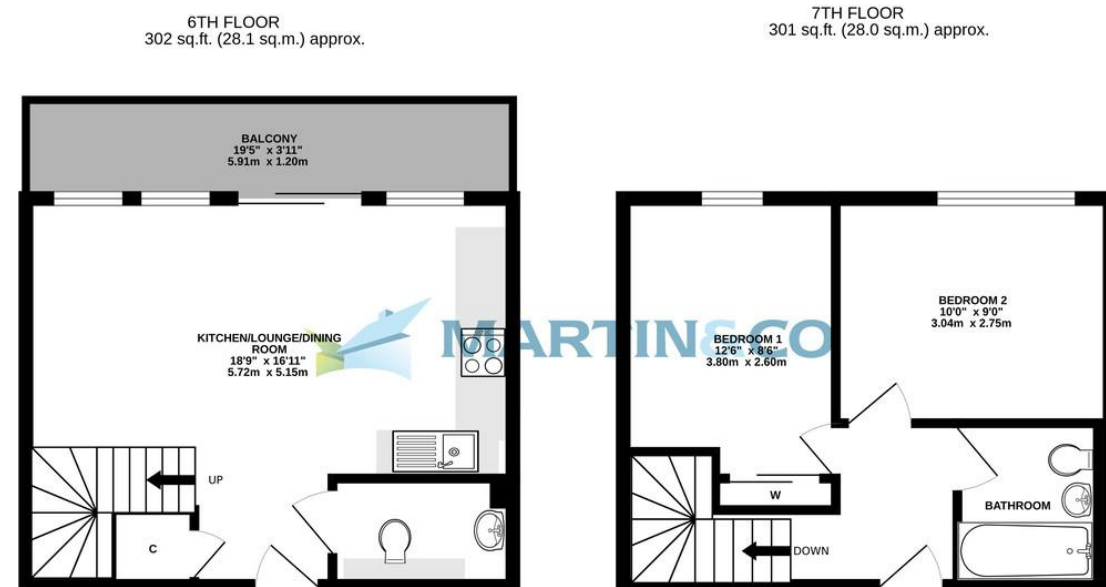

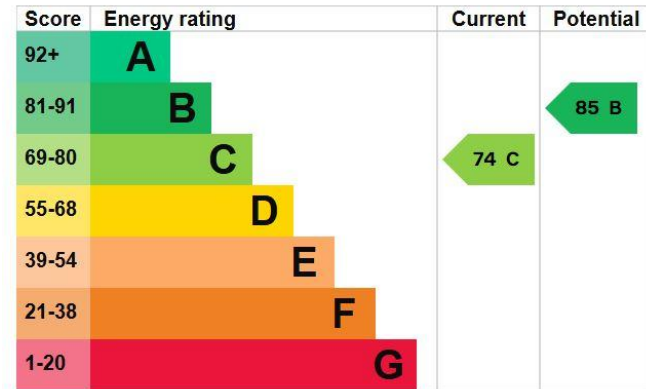
A split-level two bedroom apartment in the popular Skyline Plaza development, located in the town centre next to the train station and Festival Place shopping centre.

Comprising an 18' lounge/dining room, balcony, kitchen area with appliances, cloakroom/utility room, two bedrooms, bathroom and secure gated parking.

LOUNGE/DINING ROOM 18' 9" x 16' 10" (5.72m x 5.15m) Side aspect windows with sliding door to the balcony, laminate flooring, storage cupboard and electric radiators.

KITCHEN AREA A range of eye and base level storage units with rolled edge work surfaces, integrated oven, four ring electric hob, fridge/freezer, dishwasher and laminate flooring.

CLOAKROOM/UTILITY ROOM 6' 10" x 4' 3" (2.09m x 1.3m) Low-level WC, wash hand basin, washing machine, electric radiator and tiled floor.



BALCONY 19' 4" x 3' 11" (5.91m x 1.2m) Decking base with glazed surround.

LANDING Door to the 7th floor, carpet and radiator.

BATHROOM 7' 11" x 6' 0" (2.42m x 1.84m) Bath with shower over, low-level WC, wash hand basin, electric towel radiator and tiled floor.

PARKING There is secure gated allocated parking for 1 car.

APPLICATIONS A holding deposit equivalent to 1 weeks rent will be required to reserve the property while referencing checks are being carried out. Failure to do so for any of the afore mentioned reasons may result in you losing your holding deposit. An extension to the deadline may be entered into if agreed in writing by all parties.



Right to Rent Checks
