The property also benefits from gas fired central heating and one gated, allocated parking space.

LOCATION

The property is located towards the Southern end of Gower Road which is an established residential road running between Haywards Road and Ashenground Road, just to the west of the main town centre shops of South Road and Sussex Road and is ideally placed within walking distance of Victoria Park and Ashenground

Woods. The town has an extensive range of shops, stores, restaurants, cafes and bars as well as numerous

leisure groups, sports club and the leisure centre. The railway station is within a mile and provides fast commuter services to London (Victoria/London Bridge 47 mins), Gatwick Airport (15 mins) and the South

coast (Brighton 20 mins). A regular bus service runs



close by and access by road to the major surrounding areas can be gained via the A272 and the A/M23, the latter lying approximately 5 miles to the west at Bolney or Warninglid.
