ENTRANCE HALL uPVC entrance door, central heating radiator, laminate flooring, 3 storage cupboards and stairs leading to the first floor.

DSS applicants will require a guarantor who is working and able to provide proof of an income 3x the annual rent. We will also carry out employment checks, affordability checks, previous landlord reference and proof of address history, usually up to 3 years.
